The IG BAU offers special membership for migrant workers. Here, you can become a member when you:

- ü are only working temporarily in Germany and,
- **ü** work in agriculture or the construction industry, and
- **ü** your actual home is not in Germany.

Membership as a migrant worker ends automatically after 12 months, but can be renewed every year. From the very first day, membership includes:

- **ü** free advice and information.
- ü representation in court in cases concerning employment rights and civil rights,
- ü support when your employer tries to make responsible for damage to their property or vehicles.

The membership dues are much lower than normal as migrant workers are only temporarily in Germany. Detailed information is on the last page.
