<sup>1</sup> Migrant workers in the construction and agricultural industries can become annual members of IG Bauen-Agrar-Umwelt in accordance with Section 8 (8) of the Berlin Statutes 2017, as decided by the Trade Union Advisory Council on 28.01.2020.

Membership begins with the payment of contributions and ends after twelve months without notice, unless it is renewed.

The annual fee is charged for 12 months in advance. The fee is significantly lower than for regular membership.

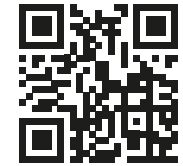
